#### **AAWCC Board Retreat**

### January 27, 2017

**CALL TO ORDER** – The retreat was called to order at 8:20 p.m.

**AGENDA CHANGES** – None were made.

#### **DISCUSSION ITEMS**

Retreat Goals – Lynn provided a brief overview of the weekend's goals.

Approval of Minutes – Cherie's motion to *approve the minutes dated October 26 and 28, 2016, as presented,* was seconded by Julie Kopet. Upon call for the vote the *MOTION PASSED* unanimously.

**President's Report** – Lynn thanked everyone for participating.

Past President Report – No report given.

**Financials** – Copies were distributed. Cherie reported that \$7,100 was made from Fall Conference. She briefed us on the Tax ID # issue she's dealing with. She explained that in April 1976, the Tax ID # was set-up under the American Association of Women in Community and Junior Colleges: Council of the American Association of Community and Junior Colleges Chapter. Because it doesn't match with our current state chapter name, the IRS and Key Bank is going to start charging us penalty fees. We have to either change our chapter name or try to change our Tax ID #. More research needs to be done. It was noted that PayPal stopped working because of the Tax ID # issue.

Cherie indicated that the state chapter pays national a \$550 membership fee and \$2,120 for the 212 members (\$10/each). Active members are considered anyone that has participated in a conference this year. Lane and Chemeketa are national members so the state chapter doesn't pay for their members' national dues, but does for the rest of the state members.

Discussion occurred on the account balances and what it takes to do a Fall Conference. We may need to transfer back the \$10,000 to savings.

The conference spread sheet that Carol McKiel developed was mentioned as a great way to track and project event expenses. Cherie announced that she's running for the national board again.

**By-Laws** – No work was done at this time.

**Website** – Board section updates should be sent to Lydia. The Summer Conference dates have been posted and the schedule would be as well once it's available.

Analytics – (the tracking of our site's visitors) - In October, we had 700 hits from 300 people; November we had 1,000 hits from 300 people. After a year of data collection we can determine if we've improved. We could also make version of the page with other information to see which page has a higher conversion rate.
