Approval of Minutes – Deb's motion to approve the minutes dated September 28, October 24, November 7 and November 9, 2019, as presented, was seconded by Julie Kopet. Upon call for vote the MOTION PASSED unanimously.

Financials – Copies were distributed. Cherie reported by phone the following:

- Checking \$3,727.02
- Savings \$4,392.76
- CD \$10,562.37
- TOTAL \$18,682.15
- Didn't get the last transfer in, ending fund balance is back to 8,000 in savings.
- The 10,000 annuity coming due March 6, really hoping not to have to pull that money out and close the account to put it in savings.
- \$1,000 to embassy suites
- Paid national \$2,126, plus still owe \$550 and \$910 from last year. Coming due in August. They are fine with us owing until we bring in more revenue.
- Hope to get more people to pay the institutional dues. Maybe get off the lifetime membership fee and charge the colleges for state memberships. Costs go up and up.
- Fall conference, lost about \$2,000, believe because of speaker costs. We would still have to pay for travel
- OILD ways to save money?? Brochure went out for \$625 instead of \$750. We could add a couple more people, change locations. It was agreed to send out the updated brochure with the correct amount.
- Motion to re-establish \$750, Deb will send email to all Executive Assistants and Campus
 Contacts with corrected brochure. Julie moved to send out revised email with new amounts,
 Deb seconded the motion, motion passed unanimously.
